1.2 The procedure and fee structure for getting information are as under:-

(a) A request for obtaining information under sub-section (1) of Section 6 of the Right to Information Act shall be made in writing or through electronic means either in person or by post to the Public Information Officer mentioned in paragraph 1.1 above and must be accompanied by an application fee of Rs.10/- by cash or by affixing court fee stamp or by postal money order or by demand draft or banker's cheque. The Public Information Officer shall credit the amount to the following head of account.

- (b) For providing information under sub-section (1) of section 7 of the Right to Information Act, the request shall be made as at (a) above and the fees as below should be paid as per the mode at (a) above.
 - (i) Rupees two for each page (in A-4 or A-3 size paper) created or copied;
 - (ii) actual charge or cost price of a copy in larger size paper

- (iii) actual cost or price for samples or models; and
- (iv) For inspection of records, no fee for the first hour; and a fee of Rs.5/- for each fifteen minutes (or fraction thereof) thereafter.
- (c) For providing the information under sub-section (5) of section 7 of the Right to Information Act, the request shall be made as at (a) above and the fee as below should be paid as per the mode at (a) above.
 - (i) for information provided in disc or floppy @ Rs.50/- (fifty) per disc or floppy; and
 - (ii) For information provided in printed form, at the price fixed for such publication.

Persons below the poverty line are exempted from the payment of fee mentioned in paragraph 1.2 above for seeking information under the Right to Information Act, 2005. The list of persons below poverty line approved by the Gram Panchayat and Local Bodies will be the basis for claiming this concession. An extract of the list, duly certified, will be sufficient to avail this concession.

Particulars of organizations, functions and duties under section 4(1)(b)(i) of Right to Information Act, 2005

1. Objective / Purpose of the Department

Directorate of Art and Culture is headed by Commissioner / Director of Art and Culture. It controls and regulates the functions of all the Govt. institutions related to Art and Culture. The functioning of Govt. Music colleges, Govt. Music schools, Govt. college for Fine Arts, Govt. college of Architecture and Sculpture, Jawahar Siruvar Manram and Oviya Nunkalai Kuzhu are supervised and administered by the Directorate in an effective manner. The Directorate is now functioning in the premises of Department of Art and Culture, Egmore, Chennai – 08.

2. Information and Public Relations

The Information and Public Relations wing assists the government to ameliorate the conditions of the people, educating illiterate and poor, by providing basic information about available opportunities and modern production methods through various channels i.e Tamil Arasu, Advertisement and Exhibition. Tamil Arasu is the official magazine of Government of Tamil Nadu which convey information about achievements and various schemes of all government departments

Powers and duties of officers and employees under section 4(1)(b)(ii) of Right to Information Act, 2005

This department is headed by the Director of Art and Culture who is an I.R.P.F.S officer. The Director is the administrative head of the Department. He is assisted by Joint Director, Deputy Directors and Accounts Officer. The Officers and Employees of this Department exercise the administrative and financial powers as laid down in the Tamil Nadu District Office Manual and Tamil Nadu Financial Code. The powers and duties of the officers in the Department are indicated below:-

a) Director

The Director is the head of the Department. He exercises general supervision and control the staff of the subordinate offices and he is responsible for seeing that the subordinate officers do the work allotted to them efficiently and expeditiously. Policy matters and all important matters should be dealt with in consultation with the Director who will be in over all charge of the Department.

The Joint Director is the second level officer of the Department. The Joint Director has the administrative control of the entire department under the guidance of the Director.

c)Deputy Director (Admin)

- 1) All establishment related works of Directorate and all Subordinate Offices, Preparation of Estimate of vacancy, Teachers recruitment, Pay Fixation, increments to all staffs, orders issued to selection grade and special grade movement of the staff, promotion, training and disciplinary actions related files scrutinized and sent to Joint Director and Commissioner / Director for approval.
- 2) CM Cell Petitions, RTI Petitions, Annual reports, Government requested proposals, Legislative assembly questions, Assurance committee, Assembly announcement related files, district administration and private art associations request related files scrutinized sent to Joint Director and Commissioner / Director for approval.
- 3) Hon'ble Chennai High Court, High Court Madurai Branch, Supreme Court cases related to this department will be monitoring periodically and taking steps to reduce the pendency of the court.
- 4) Administration of Seven Colleges, 17 District Music Schools, Jawagar Bal Bhavan under the control of Department of Art and Culture will be inspected by Deputy Director and submit the report to Joint Director and Commissioner / Director for approval.
- 5) Preparation of Rectification report of Audit Paras, AG Inspection and HR Implementation.

d)Deputy Director (Programmes and Art Education)

- 1) Taking steps to get the approval of the Commissioner/Director and Joint Director for the planning and implementation of the Cultural programs for conducting festivals and trainings workshop of the Department of Arts and Culture.
- 2) The Deputy Director is responsible for developing and implementing programs and schemes aimed at promoting art education and cultural enrichment. This may involve designing curriculum frame works, organizing workshops, exhibitions, and cultural events, and collaborating with educational institutions and cultural organizations.

- 3) They participate in formulating policies and strategies related to art education and cultural development, contributing their expertise and insights to help shape the organization's vision and goals in this area.
- 4) They are often involved in budget planning and resource allocation for art education programs and initiatives. This includes preparing budgets, monitoring expenditures, and ensuring that funds are utilized efficiently and effectively.
- 5) Preparation of Rectification report of Audit Paras, AG Inspection and HR Implementation.
- 6) They oversee the development of art education curricula and teaching materials, ensuring that they are aligned with educational standards and objectives. This may involve collaborating with educators, curriculum specialists, and artists to design engaging and effective learning experiences.
- 7) To Monitor the educational syllabus, teachers efficiency and examination conducted in the educational institution under the department of art and culture and give periodical reports to Director and Joint Director
- 8) Conducting Inspection in Educational institutions under the Department of art and culture ensure the education quality and sent periodical reports to Director and Joint Director.
- 9) The Deputy Director engages with various stakeholders, including educators, artists, cultural institutions, government agencies, and community groups, to build partnerships and collaborations that support the organization's objectives in art education and cultural development.
- 10) They may organize training programs and workshops for art educators, providing them with opportunities to enhance their skills, knowledge, and pedagogical approaches. This supports the professional development of teachers and promotes excellence in art education.

- 11) The Deputy Director evaluates the effectiveness of art education programs and initiatives, using various assessment methods to measure outcomes and impact. This information is used to inform decision-making, refine program strategies, and ensure accountability.
- 12) They engage with the community to promote awareness and appreciation of the arts, organizing outreach activities, public events, and community-based art projects that foster cultural participation and enrichment.
- 13) They may conduct research on art education trends, best practices, and innovations, contributing to the field's knowledge base and advocating for the importance of arts education in schools and communities.
- 14) Overall, the Deputy Director provides leadership and direction for the organization's efforts in art education and cultural development, managing staff, resources, and partnerships to achieve the organization's mission and objectives in this area.

e) Accounts Officer

He is responsible for accounts of Department of Art and Culture and he sends periodical reports to the Director

f) Assistant Director

- 1) Assistant Director is the controlling officer for the Regional Art and Culture Centre.
- 2) Assistant Director are incharge of conducting Cultural Programmes and training workshop in regional level (Controlling Districts) and send related reports to Commissioner / Director of Art and Culture.
